



## **QCP CORPORATE CHALLENGE**

### **AGREEMENT REGARDING RISK OF INJURY AND RELEASE WAIVER OF ALL CLAIMS**

I hereby apply to participate in the QCP Corporate Challenge (the “Challenge”) which will be held in downtown Zanesville, Ohio on Thursday, May 21st, 2026.

I understand that participating in the Challenge will expose me to above normal risks of injury or harm. These risks include uneven or hazardous playing surfaces, physical contact or collisions with other participants, spectators or inanimate objects about the Challenge course or events. I understand that such activities can be in itself hazardous and may result in injury to my person or property.

I represent that I have no health or physical problems that will interfere with my participation in the Challenge.

I agree that I am responsible for my own safety.

I hereby assume all risks associated with my attendance and participation in the Challenge.

I understand that I am solely responsible for any injuries which may occur to me as a result of my participation in the Challenge and I specifically waive my right to bring any actions, claims, demands or lawsuits against the Sponsors, their volunteers, officers, directors, agents, employees or representatives, successors and assigns (collectively referred to as “Challenge Sponsors”) and specifically release any right(s) which I have to assert a negligence or other claim(s) against the Challenge Sponsors resulting from any injuries or damages to my person or property arising out of my participation.

I hereby fully and forever release, discharge, and agree not to sue Quality Care Partners (QCP), and any other sponsors, collectively referred to as “Challenge Sponsors”, their officers, directors, agents, employees, representatives, volunteers, successors and assigns for any and all claims, causes of action or liability for any injury, loss or damage sustained or incurred by me or my property arising out of or in any way associated with my attendance at or participation in the Challenge, including all claims, causes of action or liability arising out of the negligence of Challenge Sponsors, volunteers, their officers, directors, agents, employees or representatives, successors or assigns.

I agree to indemnify and hold harmless the Challenge Sponsors from any loss, damage or expense sustained or incurred by the arising from any such claims, cause of action(s), or liability, whether brought by me, or anyone acting on my behalf, or by anyone else as a result of my participation in the Challenge event or my conduct or actions attributed to me.

In consideration of participation in the Challenge, I agree that my likeness may be photographed or videotaped and that such image may be published in an outlet used to promote or publicize the Challenge event now or in the future.

I understand and agree that this Agreement shall be interpreted according to the laws of the State of Ohio and shall be binding upon my heirs, successors and assigns and any person or entity acting on my behalf, including a parent, guardian or attorney-in-fact.

I acknowledge that I have fully read all of the above items of this Release and Waiver Agreement, understand them, agree to abide and honor the same.
